OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. The sponsors of the _____ Sharon Montrose sweepstakes _____ (the "Promotion") are Etsy, Inc. (owner and operator of Etsy.com) at 55 Washington Street, Suite 512, Brooklyn, NY 11201 and _____ Sharon Montrose _____ (together, the "Sponsor").

1. **ELIGIBILITY:** Open to legal residents of the 50 United States and District of Columbia age 18 years or older at the time of entry. Sponsor's designated computer is the official time keeping device for all aspects of the Promotion.
3. **HOW TO ENTER THE PROMOTION:** No purchase necessary. A purchase will not improve ones chance of winning. The Promotion is open residents of the United States. Enter the Promotion by Leaving a comment on the article Handmade Portraits: Sharon Montrose (<http://www.etsy.com/storque/handmade-life/handmade-portraits-sharon-montrose-7539/>). All entries must be received by the End Date. Limit one (1) entry per person. Mechanically reproduced, computer generated, incomplete or illegible entries are void. All entries become the property of Sponsor and will not be returned or acknowledged.
4. **PRIZES:** One (1) winner will receive 1 large baby giraffe print(the "Prize") for embedding the video on their blog and the other one (1) winner will receive 3 small animal prints (the "Prize").
