

The Alabama Chanin Sweepstakes OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The sponsor of The Alabama Chanin Sweepstakes (the "Promotion") are Etsy, Inc. (owner and operator of Etsy.com) at 55 Washington Street, Suite 512, Brooklyn, NY 11201 and Alabama Chanin, Inc. (the "Sponsor").

1. **ELIGIBILITY:** Open to legal residents of the 50 United States and District of Columbia age 18 years or older at the time of entry. Employees, directors and officers, and their immediate families (spouse, parents, children, siblings, and their respective spouses), and their respective household members, of the Sponsor and its affiliates, subsidiaries, and divisions and the Sponsor's advertising and promotion agencies are not eligible to enter. The Promotion is subject to all federal, state, local, provincial, and municipal laws. All deadlines and time periods found in these Official Rules will be based on United States' Eastern Time or the correlative time based on Greenwich Mean Time found at <http://www.timeanddate.com/worldclock/>. Sponsor's designated computer is the official time keeping device for all aspects of the Promotion.
3. **HOW TO ENTER THE PROMOTION:** No purchase necessary. A purchase will not improve ones chance of winning. The Promotion is open residents of the United States. Enter the Promotion by leaving a comment on the Etsy.com blog article "Handmade Portraits: Alabama Chanin". All entries must be received by the End Date. Limit one (1) entry per person. Mechanically reproduced, computer generated, incomplete or illegible entries are void. All entries become the property of Sponsor and will not be returned or acknowledged.
4. **PRIZES:** One (3) winners will receive one Alabama Studio Sewing + Design book and Alabama Studio Stock Kit (the "Prize). Approximate retail value (ARV) of each Prize is \$35.00 USD (AVR). Total ARV of all Prizes to be awarded: \$105.00 USD. The Prize may not be transferred, substituted or redeemed for cash, except at the Sponsor's sole discretion. Specifics of the Prizes are in Sponsor's sole discretion. Sponsor reserves the right, in its sole discretion, to award a Prize of equal or greater value if advertised Prize, or a portion of the Prize is unavailable. A list of the winners will be posted on or around within sixty (60) days of the End Date. Potential winners may be asked to provide certain information to Etsy within a reasonable timeframe. Failure to provide this information to Etsy within the timeframe may deem the Prize forfeited and Etsy will award the prize to an alternate winner. Limit one (1) Prize per person. In the event a winning entry is discovered to be invalid for any reason whatsoever or the person who submitted the winning entry fails to comply with these Official Rules prior to delivery of the Prize, the Prize may be forfeited and awarded to an alternate winner.
