Etsy Style and Accessories Giveaway Promotion OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

1. The sponsor of the **Etsy Style and Accessories Giveaway Promotion** (the "Promotion") is Etsy UK Limited, 35 Great St Helen's, London, EC3A 6AP (the "Sponsor").
2. **ELIGIBILITY:** Open to legal residents of the United Kingdom, age 18 years or older at the time of entry. You must also have an Instagram account. Employees, directors and officers, and their immediate families (spouse, parents, children, siblings, and their respective spouses), and their respective household members (whether related or not), of the Sponsor and its affiliates, subsidiaries, and divisions and the Sponsor's advertising and promotion agencies ("Promotion Entities") are not eligible to enter. Void where prohibited.
3. **PROMOTION TIMING/DESCRIPTION:** The Promotion is between 12:01:00 AM GMT+1 ("GMT") on September 22nd, 2017 and 11:59:00 PM GMT on October 1st, 2017 (the "Promotion Period"). Sponsor's designated computer is the official time keeping device for all aspects of the Promotion.
4. **HOW TO ENTER THE PROMOTION:** The Promotion consists of one (1) prize. To be eligible to participate in the draw for these prizes, Entrants must a) follow the @EtsyUK Instagram account b) "like" the post on the @EtsyUK Instagram account in connection with the Promotion and c) comment with an answer to the question, "What's your bag style?" in the comments section of the post on the @EtsyUK Instagram account in connection with the Promotion.

Your post must be uploaded in accordance with the Instagram Terms of Service (<http://Instagram.com/about/legal/terms/>). You must have an Instagram account to enter via Instagram and have your account privacy settings set to "Off". Potential winners may be required to show proof of being the authorized account holder of the Instagram account associated with the entry.

Sponsor has the sole discretion to determine whether a post qualifies as a Submission. Any Entry not in compliance with the above and which does not meet the requirements of these Official Rules will be disqualified. By entering, you understand and agree that your post may (in Sponsor's sole discretion) be posted online for consumers to view on the Sponsor-selected sites. Sponsor will only be posting select photos and posts (in their sole discretion). Sponsor reserves the right to remove any posted posts, in its sole discretion, even if the post has already been made available to the public.

Any attempt by any Entrant to submit entries by using multiple/different email addresses,

identities, registrations and logins, or any other methods will void that Entrant's Entries and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. All Entries become the property of Sponsor and will not be returned or acknowledged. In the event of a dispute over the identity of an online entrant, entry will be deemed submitted by the authorized account holder of the Instagram account. "Authorized account holder" is defined as the natural person who is assigned to is defined as the natural person who is assigned an Instagram account.

5. **PRIZE:** One (1) eligible winner will be selected in respect of the prize and, subject to compliance with these Official Rules, will be awarded the prize. The prize consists of the choice of a bag up to the value of GBP £500.00 offered for sale on www.etsy.com by one of a select number of UK sellers. Sponsor will provide the winner with a list of select sellers from which they may choose to receive a bag. The Prizes may not be transferred, substituted or redeemed for cash, except at the Sponsor's sole discretion. All fees, federal, state, local taxes or other expenses relating to the use, acceptance and possession of prize are the sole responsibility of the winner.
6. **DETERMINATION OF WINNERS:** One (1) eligible winner for the prizes will be selected in a random drawing to be held on or about 12:00 AM GMT in Etsy's office in London on October 5th to select one (1) potential winner. This draw will be made by computer, with EXCEL software's random draw function, under the surveillance of an employee of the Etsy Marketing department.
7. **WINNER NOTIFICATION:** The potential winner will be notified via the Instagram account used for entry. If the potential prize winner does not respond to the winner notification message, or if the potential prize winner does not return the notification or if an Entrant is otherwise found to be ineligible, does not provide required information, or if the selected winner cannot accept or receive the prize for any reason, the potential prize winner will forfeit the prize and an alternate winner may, in the sole discretion of the Sponsor and time permitting, be selected from among the remaining eligible entries. The Sponsor reserves the right to modify the notification procedures in connection with the selection of an alternate winner. All decisions and results of Sponsor are final and binding.
