The sponsor of the Etsy Weddings West Elm Pop-up Promotion (the "Promotion") is Etsy UK Limited, with its registered address at 35 Great St Helen's, London, EC3A 6AP (the "Sponsor").

1. **ELIGIBILITY:** Open to legal residents of the United Kingdom, age 18 years or older at the time of entry. You must also have a registered account on Facebook.com or Instagram.com. Employees, directors and officers, and their immediate families (spouse, parents, children, siblings, and their respective spouses), and their respective household members (whether related or not), of the Sponsor and its affiliates, subsidiaries, and divisions and the Sponsor's advertising and promotion agencies ("Promotion Entities") are not eligible to enter. To be eligible to participate in the draw for these prizes, Entrants must go to either Etsy UK's Facebook page at <https://www.facebook.com/EtsyUK/?fref=ts> or Etsy UK's Instagram account at @EtsyUK and (i) "like" the post posted on that page in connection with this Promotion; and (ii) leave a comment under that post answering the question: "What is the colour scheme and/or style of your wedding?". One entry per person only.

Your post must be uploaded in accordance with the Instagram Terms of Service (<http://instagram.com/about/legal/terms/>), or, if you enter via Facebook, your post must be uploaded in accordance with the Facebook Terms of Service (<https://www.facebook.com/terms>). Potential winners may be required to show proof of being the authorized account holder of the Instagram or Facebook account associated with the entry.

"Authorized account holder" is defined as the natural person who is assigned to an Instagram or Facebook account.
